



## 1 Installation

### Installation Environment:

- Indoor use only.
- The minimum bearing weight of the wall or other places should be 3 times heavier than the device weight.



1 Fix 3 SC-KA4X45 screws to the wall, and 3 to 5 mm thread should be reserved on the top of the screw (to facilitate subsequent hanging of the chassis).

2 Open the chassis cover and press the holes on the chassis body with the screws reserved on the wall. Then attach the chassis from top to bottom onto the screws.

3 Close the chassis cover to complete the installation.




#### ● Wiegand Wiring




#### ● RS-485 Wiring




#### ● Door Lock Wiring




#### ● Door Contact Wiring




#### ● Exit Button Wiring

## 3 Activation

You are required to activate the control panel first before you can use the control panel. Activation via SADP, and activation via web are supported.

The default values of the terminal are as follows:

- The default IP address: 192.0.0.64
- The default port No.: 80; 443
- The default user name: admin

### ● Activate Device via Web Browser

1. Enter the device IP address in the web browser (192.0.0.64).
2. Create a password in the pop-up window.
3. Confirm the password, and activate the device.

Make sure the IP segment of the device and the computer is the same.



#### STRONG PASSWORD RECOMMENDED-

We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.


## 4 Other Operations

Hold the restore button for 5s to initialize the hardware.


### ● Fire Relay NO/NC
